

## APPLICATION FOR BP ROYALTY SCHOLARSHIP

The BP Royalty Scholarship Fund was established by the class action settlement in the case of *Eatinger v. BP America Production Company*, Case No. 07-1266-EFM, in the United States District Court for the District of Kansas. The case was prosecuted by Gene R. Eatinger as Class Representative and the firm of Gunderson Sharp, L.L.P. as Class Counsel on behalf of a Class defined as:

All royalty owners of BP America Production Company (and its predecessors and successors) from wells located in Kansas that have been paid royalties for gas and/or gas constituents (such as residue gas or methane, natural gas liquids, helium, nitrogen, or condensate) before January 1, 2012 and whose gas was processed at BP's Jayhawk Processing plant. Excluded from the Class are: (1) the Mineral Management Service (Indian tribes and the United States); (2) Chesapeake Energy Corp., Chesapeake Operating Inc., Chesapeake Royalty, and any Chesapeake affiliated entity; (3) Defendant BP, its affiliates, predecessors, and employees, officers and directors; and (4) any claims for Gathering Charges.

The BP Royalty Scholarship Fund is to fund or pay one or more scholarships to one or more Colleges, Universities, or Community Colleges for a person having a parent, grandparent, uncle or aunt who was a member of the Class, or if none, of a Kansas royalty owner in a Southwest Kansas well producing some gas. Adopted children are treated the same as natural born children of the adoptive parents and their relatives. All determinations of the Trustees will be final and the Trustees, in their sole discretion, can decide to grant or not grant a scholarship and decide the amount of any scholarship.

Documentation showing that the Applicant is the son, daughter, grandson, granddaughter, niece, or nephew of a member of the Class or, if not, of a royalty owner from a Southwest Kansas well producing some gas. Any person who was adopted is treated the same as a natural offspring of the adopting persons.
5. The name, address, title, phone number, and email address if available of the person at the College, University, or Community College that you plan to attend who can arrange to receive and apply any Scholarship Funds to your account in the event that you are awarded a Scholarship.
6. The Trustees may ask you to provide additional information.
